Note: Out of a forum on "Homosexuality and the Church" at Louisville Presbyterian Theological Seminary on Apr. 20, 2008 came a two-page bibliography of references that excluded every book defending the scriptural standard of a male-female prerequisite for sexual relations. It contained 13 books and articles, of which 11 works were devoted exclusively to the homosexualist agenda and two books consisted of articles on both sides of the debate but predominantly the homosexualist side. Not a single mention was made of any of my work. This list circulated privately to some people for further suggestions.

The new version continues to single out the work of David Fredrickson as an especially important piece without any mention of the fact that I have an extensive, 34-page critique of Fredrickson's article that refutes every significant argument that he makes (which, incidentally, can be easily viewed online, in addition to the print copy). I have debated Fredrickson in the past and he now refuses to debate me on the grounds that (his words) I am able to "clean his clock." The new version continues to indicate that Dale Martin's work is "brilliant" even though both the email exchange that I had with him and my beginning refutation of his book, both available on my website, would suggest otherwise. The revision continues to cite the work of Myers/Scanzoni (plus an article by Myers and another book by Scanzoni) but again makes no mention of the 110page critique that I have made of the book, also readily available online. The new version makes no mention of my "Two Views" book with Dan O. Via, despite the fact that many have considered it the best short book representing both sides. The new version adds the book by Jack Rogers but makes no mention of the 60 pages of critique that I have online at my website. The new version continues to cite Stacy Johnson's book and a website piece by him but makes no mention of my recent audio talks at Princeton Seminary (total: 5 hours) critiquing the main premises of Johnson's work. The revision still makes no mention of the works of Webb, Hays, Schmidt, Swartley, Zehnder, Chambers, Jones, or Nolland, Granted, one can't fit everything in a 2-page handout. Yet one could do a lot more to achieve balance than the lopsided 9 to 1 ratio that now exists. Will the theological left ever play fair with the evidence available? I suspect that they know that to do so would show just how weak their case really is.—Robert Gagnon, April 23, 2008.

The Bible and Homosexual Practice: Texts and Hermeneutics (Nashville: Abingdon, 2001).

Gagnon, an Associate Professor of New Testament at Pittsburgh Theological Seminary, has written what is arguably the most comprehensive work on the subject of Scripture and homosexual practice. This 500-page book gives thorough coverage to the Old Testament witness in its ancient Near Eastern context, the witness of early Judaism in its Greco-Roman context, the witness of

Jesus, the witness of Paul, and the problems with the major hermeneutical arguments used to discount the witness of Scripture, including the misuse of science.

With Dan O. Via, *Homosexuality and the Bible: Two Views* (Minneapolis: Fortress, 2003).

In his short book consists of a 40-page essay by Dan O. Via that makes the homosexualist case and a 50-page essay by Robert Gagnon that makes the complementarian case; each then offers a 6-page response to the other's essay. Gagnon's work contains note numbers that key to online companion piece, "Notes to Gagnon's Essay in the Gagnon-Via *Two Views* Book" (2003; 50 pgs.; http://www.robgagnon.net/2Views/HomoViaRespNotesRev.pdf). See also: "Rejoinder to Dan O. Via's Response" (2003; 29 pgs.; http://robgagnon.net/2Views/homoViaRejoinder.pdf). This book is a good place to begin an exploration of both sides of the debate.

This lengthy 112-page article synthesizes and updates Gagnon's previous work through critical interaction with the Myers/Scanzoni book. This is the place to go for arguments against a homosexualist reading for someone who wants more documentation than the 11-page article above without reading 500 pages. Also provides an updated discussion of science issues.

"Does the Bible Regard Same-Sex Intercourse as Intrinsically Sinful?" in Christian Sexuality: Normative and Pastoral Principles (ed. R. E. Saltzman; Kirk House, 2003), 106-55.

This 50-page article makes the case for Scripture's absolute, exceptionless indictment of homosexual practice. It focuses mainly on the use of the creation texts and on Paul's views in relation to orientation theories in the Greco-Roman world. The article interacts critically with an essay by Mark Allen Powell (a Lutheran NT scholar) entitled "The Bible and Homosexuality," which appeared in *Faithful Conversations: Christian Perspectives on Homosexuality* (ed. J. Childs; Fortress, 2003), 19-40.

"A Comprehensive and Critical Review Essay of Homosexuality, Science, and the 'Plain Sense' of Scripture, Part 2," Horizons in Biblical Theology 25

(2003): 179-275 (also online: http://www.robgagnon.net/articles/homoBalchHBTReview2.pdf). This 97-page article critiques the articles by Christopher Seitz, Robert Jewett, and David Fredrickson, along with a critique of David Balch's criticism of Gagnon's work. Especially important here is the critique of the important article by Fredrickson on pp. 206-39. This published article critiques one of the best homosexualist readings of the Old Testament, the article by Phyllis Bird in the Balch volume (cited above). Good for Gagnon's views on the creation texts, Sodom and related stories, homosexual cult figures (the *qedeshim*), and the Levitical prohibitions.

"Sexuality," in *Dictionary for Theological Interpretation of the Bible* (eds. K. J. Vanhoozer, et al; SPCK / Baker Academic, 2005), 739-48. Uses Jesus' sexual ethics as a basis for examining sexual ethics in Scripture generally and Scripture's treatment of homosexual practice in particular.

"Homosexuality" in *New Dictionary of Christian Apologetics* (eds. C. Campbell-Jack, et al.; Intervarsity Press, 2006), 327-32.

Develops a philosophic nature argument for why homosexual practice is wrong.

"Case Not Made: A Response to Prof. John Thorp's "Making the Case" for Blessing Homosexual Unions in the Anglican Church of Canada" (2007, 30 pgs.; online: http://www.robgagnon.net/articles/homosexThorpCanadaResp.pdf). Published in *God*, *Gays*, *and the Church* (ed. L. Nolland; Latimer Trust, 2008).

A refutation of a paper written by a classics professor for the Anglican Church of Canada. Presents a relatively brief overview of arguments against affirmation of homosexual practice.

A critique of a work that has received a lot of play in the PCUSA (it is written by a former theology professor at Fuller and San Francisco Theological Seminary and moderator of the PCUSA) but is characterized by great misrepresentation of the work of others, particularly that of Gagnon, and a distinct lack of knowledge of Scripture in its historical and literary context.
